

PROVINCIAL COURT OF SASKATCHEWAN

NOTICE

The forest fires near La Ronge and other northern communities have required that further adjustments be made to the La Ronge Court Office's schedule for Monday, July 13, through Wednesday, July 15, 2015:

- 1. **La Ronge docket on Monday, July 13**: Court <u>will not</u> convene at the La Ronge Provincial Court House. However, a La Ronge judge will hold court at the Prince Albert Provincial Court House to deal with custodial cases and counsel matters that would ordinarily be dealt with in La Ronge. Lawyers having matters set for Monday can appear on their matters either in person or by phone. Any lawyer appearing by phone should fax a contact number to the Prince Albert Provincial Court House at (306) 953-3342.
- 2. **Creighton docket on Tuesday, July 14**: It is anticipated that a La Ronge court party will fly out of either Prince Albert or La Ronge to attend at Creighton to deal with the regular Creighton docket.
- 3. **Stanley Mission on Tuesday, July 14**: A La Ronge court party will not travel to Stanley Mission. However, a La Ronge judge sitting at the Prince Albert Provincial Court House will deal with Stanley Mission docket matters via a telephone link to the Stanley Mission Hamlet Hall. It is anticipated that counsel appearing on Stanley Mission matters will appear in person at Prince Albert or by phone. Any lawyer appearing by phone should fax a contact number to the Prince Albert Provincial Court House at (306) 953-3342.
- 4. **Wollaston Lake docket on Wednesday, July 15**: It is anticipated that a La Ronge court party will fly out of either Prince Albert or La Ronge to attend at Wollaston Lake to deal with the regular docket.
- 5. **Pinehouse Lake docket & trials on Wednesday, July 15**: A La Ronge court party will not travel to Pinehouse Lake. However, a La Ronge judge sitting at the Prince Albert Provincial Court House will deal with Pinehouse Lake matters via a telephone link to the Pinehouse Lake LAC Hall. It is anticipated that counsel appearing on Pinehouse Lake matters will appear in person at Prince Albert or by phone. Any lawyer appearing by phone should fax a contact number to the Prince Albert Provincial Court House at (306) 953-3342.

RCMP Provost will be instructed not to transport prisoners from Prince Albert to La Ronge, Stanley Mission or Pinehouse Lake for the above-noted days. It is anticipated that any such prisoners will be brought to the Prince Albert Provincial Court House to make a court appearance in person.

No decision has yet been made with respect to La Ronge trial matters scheduled for Thursday, July 16. If the forest fires in the La Ronge area are brought under control, those matters may be dealt with in La Ronge.
