- 41.2 submit to a search without warrant of your person and any vehicle or residence that you own, operate, control or possess by any police officer who has reasonable grounds to suspect that you are in breach of a condition of this order regarding the use, access to, possession, or control of computers or similar devices specified in this order, and if computers or similar devices are found, allow a search of the computers or similar devices. *Accused consented [Judicial discretion]*
