Mandatory Probation Conditions

1. appear before the youth justice court when required to do so.

Mandatory Deferred Custody Conditions

1. keep the peace and be of good behaviour.
2. appear before the youth justice court when required to do so.
3. report to a youth worker immediately on release, and then be under the supervision of a youth worker or a person designated by the youth justice court.
4. inform your youth worker immediately on being arrested or questioned by the police.
5. report to the police, or any named individual, as instructed by your youth worker.
6. advise your youth worker of your address of residence on release and after release report immediately to the clerk of the youth justice court or your youth worker any change
 - (i) in your address,
 - (ii) in your normal occupation, including employment, vocational or educational training and volunteer work,
 - (iii) in your family or financial situation, and
 - (iv) that may reasonably be expected to affect your ability to comply with the conditions of the order.
7. not own, possess or have the control of any weapon, ammunition, prohibited ammunition, prohibited device or explosive substance, except as authorized by this order; and
8. comply with any reasonable instructions that your youth worker considers necessary regarding any condition of this order to prevent a breach of that condition or to protect society.
